Membership Guidelines

We ask that all members:

1. Read and abide by the Vision and Mission Statement of the Third Age Trust.
2. Always act in the best interests of the U3A and never do anything to bring the U3A into disrepute.
3. Abide by the terms and conditions of the constitution.
4. Treat fellow members with respect and courtesy at all times.
5. Comply with and support the decisions of the elected committee.
6. Advise the membership secretary of any change in their personal details.

Privacy Statement

Your personal details will be held on a secure database and will be used solely for the purposes of administration and the communication of U3A Matters. They will never be supplied to an outside agency or party other than for you to receive Third Age Matters directly mailed.

Membership Fees

The membership year of Abingdon-on-Thames U3A is 1st January to 31st December.

Annual Membership is £25.

If you are applying after the start of the membership year, the fees are as follows:

- joining February to July: £25
- joining in September or October: £12.50
- joining in November: £25 which gives you membership until December of the following year.

Your membership fee includes a £4.00 capitation fee to our national organisation, *The Third Age Trust*, which provides a wide range of services and benefits, including public liability insurance cover.

If you belong to another U3A, the annual membership fee is reduced by the amount of the Capitation Fee, providing you can supply proof of membership. **However, this only applies to full year membership.**

- Setting up the hall and clearing away each meeting
- Preparing and serving teas and coffees
- Helping with groups
- Administration and technical help
