Gift Aid:

What is Gift Aid? Gift Aid is a simple way to increase the value of your subscription to Baddow & Galleywood U3A (B&G) - at no extra cost to you. If you pay tax in the UK, B&G can reclaim the basic rate tax (25%) on your subscription. So, your subscription of £6 is worth £7.50 to B&G at no additional cost or effort to you.

Do I qualify for Gift Aid? In order for B&G to reclaim the tax you have paid on your subscription, you must have paid income or capital gains tax (in the UK) for each tax year (6 April to 5 April) at least equal to the tax that all the charities or Community Amateur Sports Clubs that you donate to will reclaim on your gifts for that tax year. Other taxes such as VAT and Council Tax do not qualify.
