**Gift Aid:**

**What is Gift Aid?** Gift Aid is a simple way to increase the value of your subscription to Baddow & Galleywood U3A (B&G) - at no extra cost to you. If you pay tax in the UK, B&G can reclaim the basic rate tax (25%) on your subscription. So, your subscription of £6 is worth £7.50 to B&G at no additional cost or effort to you.

**Do I qualify for Gift Aid?** In order for B&G to reclaim the tax you have paid on your subscription, you must have paid income or capital gains tax (in the UK) for each tax year (6 April to 5 April) at least equal to the tax that all the charities or Community Amateur Sports Clubs that you donate to will reclaim on your gifts for that tax year.
