4. To receive, approve and adopt the Financial Statement for the previous year. (Copies of the Financial Statements will be available at the meeting).
5. Appointment of the Examiner - Diane Bolland
6. Proposal 1 - Amendments to the Constitution:-

Clause 7.ii - Minimum number of Executive Officers reduced from 6 to 5.
Clause 7.v - Delegation.
a. The trustees may delegate any of their powers or functions to a committee of two or more trustees but the terms of any such delegation must be recorded in the Minute book. Such a committee may have additional members who are not also trustees.
b. The trustees may impose conditions when delegating, including the conditions that:
i. the relevant powers are to be exercised exclusively by the committee to whom they delegate;
ii. no expenditure may be incurred on behalf of the Charity except in accordance with a budget previously agreed with the trustees.
c. The trustees may revoke or alter a delegation.
d. All acts and proceedings of any committees must be fully and promptly reported to the trustees.

Clause 7.vi - Extension of Officers' Times of Service. (New Clause)
When an officer is due to retire and there are no suitable candidates available, and to ensure that the minimum number of officers is maintained, the officer may be re-elected until the next AGM where they may be re-elected.
7. Proposal 2 - Third Age Matters Magazine.

As a result of increasing costs for the magazine we propose that the actual cost of the magazine, for those who request it, will be added to the annual fee starting in 2024.
8. Election of new Committee members to fill any vacancies and/or re-election if appropriate.
