GROUP FINANCES

The groups are completely independent financially and they must organise and run their own finances. However, the groups are only to hold in petty cash accounts a total sum of £25 unless approved by the Committee. All money collected over this amount shall be paid to our treasurer who will bank their money and keep a separate record. The money that our U3A holds in the main bank account for any particular group is ring fenced and can only be used for that group. The treasurer will pay any money requested by the group providing the group have the funds in the bank account to cover their request.

However, where prepayment for things like theatre tickets and coaches that have to be paid before the money can be collected from members, the convenors can make a request to the Trustees to assist with the temporary payment. These monies can be prepaid by the treasurer in advance, provided they can guarantee the money will be covered by the group's members later.

Each group should be encouraged to build up a small reserve in the ringfenced accounts, to help cover these types of expenditures.

If the nominations received, does not exceed the vacancies then the Trustees and Officers will be elected unopposed and there will be no need for a vote.

FINANCE GENERAL & SOCIAL ACCOUNTS

The U3A now has to register with the Charity Commission regardless of income.

➤ There will be now only be one bank account and all monies collected will be paid into this account albeit those monies for social events will be ring fenced. Social events will include the Theatre Group, the Dining Group and the U3A organised trips to which all members are invited.

It is considered that the Theatre Group and Dining Club are very much social events and as such the money should not be included in the General Account. Every member of the U3A will automatically be a member of these Groups and will be entitled to attend any activity held by either of these groups.

The money held in the individual accounts may only be used by each of the groups respectively.

The Treasurer will have the account audited at the end of the financial year and will present to the membership at the AGM the audited account:

The Treasurer will discuss the accounts at every third Trustee's meeting to ensure the Trustees are kept fully informed of the accounts.

At the May Trustees meeting each year the Trustees will discuss the predicted cost analysis for the following year and will set the proposed new members fees for the following year.
