Subscription payments to join Cheadle and Gatley u3a are £12 per year pro-rata, April to March; e.g. someone joining in September would pay £7 (for September to March). This subscription includes a total of £7.30 in payments to our national organisation, the Third Age Trust, which provides a wide range of services and benefits, including liability insurance cover, our online membership system, Beacon, and delivery 5 times a year of the magazine *Third Age Matters*.

In addition there is a charge of £2.00 for each Monthly Open Meeting and a similar charge for most group meetings which use a hired venue, to cover room hire.

We are very grateful to our members who have previously completed a Gift Aid form.

If you are a UK taxpayer, using Gift Aid means that for every £1 you give, Cheadle and Gatley u3a can claim another 25p from HM Revenue and Customs. This means that on a normal annual sum of £12 we can claim an additional £3 from HMRC. Gift Aid is reclaimed by the U3A from the tax you pay for the current tax year.

Once you have made the declaration, we can continue to claim on your behalf as long as you are a member. Because we don't have a 'Joint Membership' in our u3a, married couples need to complete a separate Gift Aid form each. It's not necessary to complete a Gift Aid form each year.

PRIVACY STATEMENT

Cheadle and Gatley u3a processes member information so that we can keep you informed about events, groups and activities as part of your membership. Cheadle and Gatley u3a's lawful basis for collecting this information is contract. The details you have provided are stored securely in our online Membership Management System (Beacon) which is overseen and operated by the u3a National Office.

This information is used:

- To communicate with you as a u3a member by telephone, email or post.
- To share with Group Convenors for those groups that you are a member of.
- To send you general information about the Third Age Trust (the national organisation to which all u3as are affiliated).
