MEMBERS of OTHER U3As

If you are already a member of another U3A the membership fee of £3.50 to The Third Age Trust will already have been paid by your original U3A so it does not have to be paid again.

GIFT AID NOTES

You must understand that if you pay less Income Tax and/or Capital Gains tax than the amount of Gift Aid claimed on all your donations in that tax year it is your responsibility to pay any difference.

You must notify the Membership Secretary if you:

1. Want to cancel this declaration at any time.
2. Change your name or home address.
3. No longer pay sufficient tax on your income and/or capital gains.

If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HMRC to adjust your tax code.
