- Please read pages 1 and 2 of this information sheet and then complete and sign the attached Membership Application Form. Please also sign the attached Gift Aid Declaration if you wish the u3a to claim Gift Aid on your membership fee.
- For joint memberships, details of both members must be provided but only one signature is needed.
- Bring your completed form and cheque to a monthly meeting. These are usually held from 10am-noon, on the 2<sup>nd</sup> Wednesday of each month at Dronfield Civic Hall but please check the <u>Members</u> page of the u3a's website for exact dates and times. For postal applications, please email or telephone the Membership Secretary to be given the u3a's postal address.
- Make cheques payable to Dronfield and District u3a. If you wish to pay by cash, please ensure you have the correct amount.

#### **ABOUT OUR MEMBERSHIPS**

- The u3a's membership year runs from 1st April to 31st March each year.
- For this year, the membership fee is £15, reducing to £7.50 for anyone joining from 1<sup>st</sup> January 2025. The fee covers the running costs of our own u3a plus the Third Age Trust's (TAT) annual capitation fee of £4.00.
- No reduction is given to Joint members (two members who live at the same address) or to those who belong to other u3as.
- Members may choose to receive Third Age Matters (TAM), the magazine of the u3a movement. TAM is
  posted direct to members' home addresses five times a year. Postage costs £3.80 per year in addition to
  the annual membership fee. Joint members only receive, and pay for, one copy of TAM.
- In addition to the membership fee, members may have to pay additional charges to cover the running costs of the groups to which they belong. For example, to cover meeting room hire, refreshments, specialist equipment, visit tickets etc. The groups themselves control these charges.

#### **PRIVACY STATEMENT**

Dronfield and District u3a holds members' personal details on a secure database and uses them solely for the purposes of administration and the communication of u3a matters. They are never supplied to an outside agency or party other than for members to receive Third Age Matters directly mailed.
