4. Business Secretary's Report:

It was agreed that a review of the Constitution of the Ems Valley u3a will take place in June.

The annual return has now been completed and the year end has been changed to March. The AGM which takes place on 25th May will need 51 members attending to be quorate. All the papers required for the AGM, including the Agenda, have been sent out electronically. There have been no nominations for the position of Vice-Chair. As this is an essential position to be filled, members of the committee were asked for suggestions for a possible nominee.
Geoff Wiggins volunteered to speak to someone he thought could be a possibility.
Both Geoff Whalley and Geoff Wiggins stated that they no longer wish to be nominated as a committee member.

The arrangements for the AGM were looked at in detail and it was agreed that the committee will be seated on the stage.
The current Chairman - Anne Powell - will be Chairman until the election takes place and the new chairman takes over.
At the end of the AGM the meeting will go straight into the singing group after which there will be tea and cakes for the members followed by a talk from Rod Lipscombe on being a contestant on Mastermind.

5. Treasurer's Report:

Any deficit this year will be covered by an increase in Gift Aid which will come through next year.

## 6. Membership Report:

7. Groups Report:

There is a change of Leader for the Italian Group.
Very sadly, no-one has come forward to carry on the Pubs and Churches Group, so the Group has now closed.
The proposed new Group CAMEO (Come And Meet Each Other) attracted so many enquiries that THREE Groups are now established: Group 1 has already had its first meeting; Group 2 starts in June; Group 3 is finalising arrangements and hopes to start in June. All three groups are full, and a waiting list has been opened.
It was suggested that new members attending their first monthly meeting could be taken by one of the "meeters and greeters" to sit with an existing member to help them feel welcome.
8. Newsletter: There was nothing to discuss.
9. Website: The new Siteworks framework is still in development and the Webmaster will report back in due course. Action: Tim Mathews
10. Monthly Meeting: The speaker at the meeting on 27th April was very good and the entertainment by Play Reading Group 1 was excellent. The meeting on 25th May is the AGM. Once this is completed, the singing group will perform, and tea and cakes will be served after that. This will be followed by a talk from Rod Lipscombe on being a contestant on Mastermind.
