Structural Governance and Management

Constitution - Fife U3A is an unincorporated association and a registered Scottish charity (Scottish Charity SC036555). It is governed by its constitution which was first adopted in May 2005. The current constitution was adopted on 10 May 2018.

Fife U3A is a member of the *Third Age Trust* (Registered Charity Number 288007) and is a member of the *u3a in Scotland* (Scottish Charity SC 030370).

Appointment of Trustees - trustees are elected at the Annual General Meeting which is normally held in May. Under the constitution, there must be a minimum of seven and not more than twelve trustees appointed. The trustees may co-opt a further two trustees if they consider it would be in the interests of Fife U3A to do so.

Management - the trustees are responsible for the strategic direction and governance as well as the day-to-day running of Fife U3A. Committee meetings of trustees are held regularly during the year.

Objectives and Activities

Charitable Purpose - the object or charitable purpose of Fife U3A is:

The advancement of education and, in particular, the education of older people and those who are retired from full time work, by all means, including associated activities conducive to learning and personal development, residing in Fife and its surrounding locality.

Activities - our primary activities are the provision and promotion of informal learning opportunities to reflect the aspirations and wishes of our members. Normally we hold monthly speaker meetings, groups are formed to reflect members' more specific interests, and these are complemented by occasional educational excursions to places of interest.

Achievements and Performance – After the Covid restrictions, we had started meeting in person cautiously in December 2021 and we continued meeting monthly through this year with between 50 and 60 members attending. A wide range of topics was covered, including 'The Doocots of Fife', Kirkcaldy Food Bank, Radiology in World War I, the energy support available through Cosy Kingdom and 'The Role of the Coroner'. The support of local speakers who delivered these talks is appreciated. Members Day and Christmas Celebration meetings were driven by contributions from members and their efforts were enjoyed by other members. A 'Groups in the Spotlight' feature was also introduced to highlight groups which members might care to attend. We held a summer picnic in the local area – this time in Dunfermline's Pittencrieff Park - and members also gathered for a New Year Lunch and quiz in January.

Almost all groups started up again in September 2022 and a new Scottish Heritage group was formed. Two groups did not start up and one has ceased during the year. Two new or revived groups have started at the end of this financial year. Health and Safety continued to be a priority and group leaders have been given support and assistance in ensuring groups manage risks, with a Group Leaders meeting held in October 2022.

Informal weekly gatherings of members have continued at hotels in Dunfermline and Kirkcaldy and this has encouraged activities among members and provided support and encouragement

to new and potential members who dropped in.

While our membership numbers have not quite returned to pre-covid pandemic numbers (191 reported at 31st December 2019) at 31st March we have 185 members with 42 new members joining in the year since September.

We have had continuing engagement with our members during the past year. This has been achieved by issuing newsletters on a regular basis, reducing from monthly to quarterly as more members started attending meetings in autumn 2022. Our newsletter includes information about Fife U3A, but also more general information of interest to members. The newsletters were sent out mainly by email, but also by post to those who do not use email. In August 2022 we also set up a Twitter account which has been used to post information about our activities and relevant local events and news.

Our website, with the meetings programme and details of interest groups has continued to be updated. We are awaiting information from the Third Age Trust about a new website system to replace the existing one.

Trustees

Trustee meetings since the AGM in May 2022 have been held in person. A Key Dates document was developed and existing policies have been reviewed during the year in line with that schedule. We have also established new policies for Accessibility, Social Media, and Equality, Diversity and Inclusion.

After the death of a trustee in December and the resignation of two trustees in January, the existing Committee members have continued to manage the organisation. We reached out to our members in March both in person and using a survey and had a very successful response both for potential trustees and volunteers to help in other ways. We are therefore very hopeful that we will have a strengthened committee following our AGM in May.

Financial Review

With the balance at the end of the financial year of £5,017.38, the trustees consider that we are well placed to continue our usual activities. We are expecting invoices totalling an estimated £1,560 from the Third Age Trust and the Third Age Trust Trading in April and May before our membership year starts in September 2023.

Gift Aid of £301 was received based on membership fees received during the calendar year 2022 and the trustees are grateful to our members for their generosity.

We have not yet had invoices for February and March for the venue for our Monthly Meetings. Our surplus of £879.20 for the year is therefore an overstatement by an estimated £235.

We continue to use St Bryce Kirk and the Kirkcaldy United Services Institute (KUSI) in Kirkcaldy for our meetings, as they are convenient meeting places. Some group meetings also take place in members' houses in various parts of west and central Fife and in hotel spaces and other venues.

Our main payments are for the services members receive though membership of the Third Age Trust – general support and insurances, magazine and the administration system BEACON.

Policy on Reserves

Fife U3A aims to keep a level of reserves that will cover six months of regular operating activity including fees due to the Third Age Trust for the operating year (September-August). We receive our main income in September, with major expenditure on fees in March and April. Our balance is at its lowest in July and August. In the year reported on, our lowest level of funds available was £2,780 in mid August 2022.

Donated Facilities and Services - the trustees give their time freely to attend meetings and fulfil their specialised roles, and group leaders also give their time freely, preparing and running group sessions. It is estimated that more than 1000 hours have been donated in this way during the year.

Trustee Remuneration and Expenses - trustees have not charged expenses to attend and support committee, monthly or group meetings.

Future Plans

The main plan is for the trustees to continue to support face-to-face meetings, existing and new activity groups and events in established and new venues to support the overall objective of the charity.

When we have strengthened the committee of trustees, the plan is to complete revision and updating of the constitution to align it with a new Scottish model constitution which has been provided by the Third Age Trust.
