Useful Information about GIFT AID:

Q1	What is Gift Aid?	A1	Gift Aid is an agreement with the HM Revenue and Customs to allow registered charities, like Garforth, Kippax & District U3A, to claim tax back on membership fees or donations made by members.
Q2	How do I qualify to donate Gift Aid?	A2	If you receive an income, e.g. salary, private/employer pension or annuity which is subject to tax deductions at source, or are taxed on a state pension/benefit, you qualify to donate Gift Aid.
Q3	Does it affect my tax position or cost me money?	A3	No. Gift Aid is a repayment by HM Revenue and Customs of the tax you have already paid before receiving your net pension, etc
Q4	Can I donate Gift Aid to more than one charity or organisation?	A4	Yes. Gift Aid forms can be signed for as many accepted organisations as you want – e.g. The Church by way of Covenant; RSPB; Garforth, Kippax & District U3A etc.
Q5	Is there a maximum amount I can donate as Gift Aid?	A5	Yes. The maximum amount you can sign Gift Aid forms for is the same as the total amount of tax deducted annually from your pension, etc

Gift Aid is a valuable source of income. Garforth, Kippax & District U3A, and all individual members are encouraged to join up for Gift Aid if applicable.
