PREFACE

The meeting was held using Zoom teleconferencing software, as permitted by the constitution, as amended on 1 December 2020. The process was similar to that used for the previous Annual General Meeting. Prior to the meeting members eligible to vote had received by email or post the papers for the meeting and a voting form. Valid returns had been received by the deadline (27 May 2022) from 65 members, more than sufficient to satisfy the quorum. Three questions about financial matters had been received and had been answered by the Treasurer.

1. Welcome and Apologies

The Chairman welcomed 23 members to the virtual meeting. Apologies had been received from Hazel Baxter, Ann de Voil, Vivien and Hugh James, Lilian Shute, Rachael Snashall and Phyllis Stanley.

2. Minutes of the Annual General Meeting held on 8 June 2021 and Matters Arising

The minutes of the Annual General Meeting held on 8 June 2021 had been unanimously approved. There were no matters arising.

3. Chairman's Perspective

Robert Mansfield presented a short paper, previously distributed, summarising developments during his three years as Chairman. He thanked Group Leaders and Committee Members for their support over a challenging period. Despite a decline in membership of about 100 over the three years, he believed Great Glen U3A was now in good shape to focus on innovation and growth, the priorities for the year ahead.

4. Recognition Award

The Committee had decided to recognise the outstanding contribution made by Janet Freestone, Group Leader of the Table Tennis Group. An award would be presented at the forthcoming Group Leaders' Meeting.

5. Treasurer's Report

Roger Edwards's report was taken as read.

6. Annual Report and Financial Accounts for Year ending 31 March 2022

The annual report and financial accounts for the year ended 31 March 2022 had been approved unanimously. There were no matters arising.

7. Appointment of Barry Wilford as Financial Examiner

The appointment of Barry Wilford as Financial Examiner had been unanimously approved. Robert Mansfield thanked Barry Wilford for his continuing service.

8. Election of 8 Committee Members 2022/2023

The following had been elected unanimously, or with a single abstention, to serve as Committee Members and Trustees for the year 2022/2023: Elizabeth Cooke, Roger Edwards, Janet Fanko, Patricia Mansfield, Robert Mansfield, Diane Richardson, Peter Russell and Lynda Williams.

9. Increase in Annual Subscriptions for 2023/2024 onwards

The recommended increase in annual subscriptions to £16 for full members and to £30 for two joint members had been approved by a majority of 63 votes to 2, and would therefore take effect from 1 April 2023.

10. Any Other Business

No other business had been notified.

The meeting concluded at 10.42 a.m.

CHAIRMAN'S REPORT 2022-2023 Paper B

Ladies and gentlemen, as I come to the end of my one-year stint as your chairman, I would like to thank a considerable number of members for their assistance during this year and also comment on the progress our u3a has made. I also need to raise issues of our future management.

I'm pleased to say that the year has turned out to be a successful step forward in our activities and we end the year in a sound financial position. This is good news for a year in which we celebrated our 21st Anniversary. This time last year we were finally emerging from the long period of reduced activity brought about by the pandemic. However, membership was down considerably from prepandemic numbers with obvious consequences for our financial security. It was important that we made efforts to attract more members to existing and possible new interest groups. Roger Edwards had already made a significant start to looking at what might be done and from that start we introduced a Development team of Di Richardson and Sue Russell to take things forward. As you will recall, this was initiated with a membership survey of topics which could produce new groups. The survey produced some very helpful results and Di and Sue then used this as the basis for several potential launches of new groups and the revival of former groups. The plan for this year has been completed and we have several new groups up and running. So many thanks to Di and Sue for all their efforts. And in this context I would like to thank those members who have volunteered as group leaders for the new and revived groups. Some are new to Great Glen u3a so it is a significant step to volunteer as group leader. Indeed, all our group leaders deserve our ongoing thanks for the work they do in organising our groups.

The loss of the village facilities has been especially frustrating and we are having to look further afield to find venues for our meetings. As many of you have discovered, The Fox Pond restaurant has become a regular meeting place, and it is good to find somewhere with plenty of car-parking space. But it would be very good if we could find an easily-accessible venue for our monthly meetings. These have recently moved to the Methodist Hall since the closure of the village hall but its limited capacity means we cannot accommodate the numbers we used to get pre-covid.

I would like to talk next about our committee. Here we have a very capable but small group of members who are devoting a lot of time to the continuing successful operation of our u3a. In recent years the regulations imposed on charities have increased. The operational and reporting requirements of the charities commission have to be managed and this is shared amongst committee members. But our main focus of course is to maintain and develop the ongoing pleasurable activities of our own u3a. I've already mentioned Di and Sue, so on behalf of the membership, thanks now go to Robert Mansfield- Vice Chairman and our representative at Leics & Rutland U3A Network meetings, Roger Edwards- Treasurer, Janet Fanko - Membership Secretary, Elizabeth Cooke- Business Secretary, Lynda Williams- Newsletter Editor and Patricia Mansfield-Speakers Secretary. It is now very important that new committee members come forward from our membership as some of us step down.

So we are in good shape, with lots of opportunities for members to get involved in some quite diverse subjects. At the end of my year in the chair I wish everyone all the best for the future and look forward to Great Glen u3a going from strength to strength.

Paper C

Treasurer's report 2022-23

The accounts show a surplus of over £2,000 arising from improved attendances at most groups and the 50p increase in meeting fees from September. For small groups meeting frequently and using large rooms we requested members make an additional contribution at each meeting. We opened a number of new groups in 2023 and all of these are already covering their costs.

Total income at £18,231 was nearly double last year's total as we met for the whole year rather than just over six months when we cautiously opened up and had to apply covid restrictions to our meetings.

We had a big increase in our spend on equipment. We replaced our broken speaker system for use at our monthly meetings, we bought a new cupboard for storing our equipment in the Schoolroom and a large display board for public meetings. We were fortunate to be awarded a grant by the TAT for much of the cost of the display board.

Our subscription to the Third Age Trust was higher as the rate per head increased and the one-off concession we had in the previous year no longer applied. The cost of the Third Age Trust newsletter also increased and will rise further in 2023-24. At the last AGM we therefore proposed that subscriptions for the 2023-24 would be £1 more and this will nearly cover the extra payments to the Third Age Trust.

Rent payments more than doubled and this correlates with the groups meeting all year round rather than just half the year. We are fortunate that our landlords maintained our rental terms throughout the year.

In March 2023 about half of our money in our 30 day notice account was transferred to a 100 day notice account with another bank in order to generate more interest.

ANNUAL REPORT AND ACCOUNTS 2022/23 Paper D of the Great Glen Interests Group U3A

Registered Charity Number 1099411

1. Overview of Charity

The Great Glen Interests Group U3A was established in November 2001; it is affiliated to the Leicestershire Network of u3as and nationally to the Third Age Trust (TAT). About 40% of current members live in Great Glen and 20% in Oadby, with the remainder generally from other locations within five miles of Great Glen.

The Objects are:

- to advance the education of the public and in particular the education of middle-aged and older people who are not in full time gainful employment in Great Glen and its surrounding locality, and
- to provide facilities for leisure time and recreational activities with the object of improving the conditions of life for the above persons in the interests of their social welfare.

Great Glen U3A is one of 1,050 u3as in the UK and one of about 20 in Leicestershire & Rutland. It is a self-help organisation.

2. Committee Structure and Members, and in-year Changes

The Committee of Trustees meets on the first Tuesday in each month. The members at the year-end are Chairman Peter Russell, Vice Chairman: Robert Mansfield, Groups Co-ordinator: Di Richardson, Speakers Secretary: Patricia Mansfield, Treasurer: Roger Edwards, Business Secretary: Elizabeth Cooke, Membership Secretary: Janet Fanko, Newsletter Editor: Lynda Williams and Development Co-ordinator: Sue Russell.

The Committee is supported by two non-Committee posts: Gift Aid Officer, William Maxted; and Lynn Francis, our Accessibility and Welfare Officer.

At the end of the year, the Chairman, Development Officer and the Accessibility and Welfare Officer are all standing down from their posts and from the committee. This leaves the committee having fewer trustees than would be ideal for our u3a.

3. Overview of Year

3.1 Membership

Membership is stable, with 349 members at the end of March 2023. To enable more people to benefit from our group activities, we continued to set a reduced subscription for 26 Associate Members of other u3as. The pandemic had a continuing impact on recruitment but we were pleased to see the return of some lapsed members as restrictions eased.

As from early March 2020 group meetings were suspended as a result of Covid-19. Face-to-face restarted gradually from May 2021. By the end of 2022 all groups, with the exception of Quiz, were meeting face-to-face.

The format of our Christmas entertainment reverted to face-to-face with some individual contributions. Attendance was disappointing, no doubt in part because it was impractical to collect payments before the event.

Our 21st anniversary celebration was held in October at Burton Overy Village Hall. This was a bring-and-share meal, with the anniversary cake being cut by founder member, David Brooke.

The discounted membership fee promotion featured at the September Open Day, held at Great Glen Village Hall, produced more recruits.

3.2 Venues

Our prime venue for indoor meetings continues to be the rooms at the Great Glen Methodist Church, with additional venues of Burton Overy Village Hall and Great Glen Village Hall. Our table tennis group re-started at Leicester University Sports Centre when the permanent closure of Great Glen Sports Centre was implemented. A private room at The Fox Pond restaurant has been used for the first time this year with several introductory meetings being held. The new Psychology group is meeting here each month. Facing a massive increase in fuel costs as of 1st April the Great Glen Village Hall was closed permanently. There are still unfulfilled plans for the redevelopment the sports centre and Village Hall.

3.3 New and Re-launched Interest Groups

In Autumn 2022 we surveyed members and found there was reasonable interest in establishing ten more interest groups. Interested members were invited to attend meetings to discuss how groups could be inaugurated and to choose Group Leaders and times when groups would meet. A bi-monthly Open House and a periodic Talk, Tea and Trivia session were started with the aims of fostering social interaction and member engagement. Meet & Eat had its first meal at The Bell in Burton Overy in January, and Art Appreciation and Psychology started in January and February respectively.

A second Table Tennis group started at the University on Fridays from the middle of February. A re-launched Gardening group made a start in February. Village Strollers' inaugural walk was made at the end of March with the intention to meet monthly until October. Numbers interested are more than can be accommodated at one session. The Needles and Pins group closed at its March 2023 meeting.

Meetings for those interested in Bird Watching, Poetry, Photography and Local History will be held around Easter.

3.4 Website

In March 2021 we converted our website to the TAT Site-builder application. In Autumn 2022, our ISP had an unresolved dispute with the TAT and all the core system had to be copied to a new provider. This however required the re-input of all our images and files. The TAT is currently planning a replacement website service which is expected to be launched during 2023. This is likely to require the transfer of our existing site during the next one to two years.

4. Overview of Finance

Great Glen u3a received total annual subscriptions from members of \pounds 4.5K. Our sessional income returned to close to pre-pandemic levels.

Our total income was just over £18K.

Reserves at the 2022-23 year-end were significantly in excess of the target of three months' turnover. We agreed to raise annual subscriptions for 2023/2024. In September we increased our sessional donations to $\pounds 2$ and for some small groups meeting weekly in large rooms the fee is $\pounds 3$.

In January we adopted a fee for attendances at zoom meetings and these are charged up-front for the rest of the calendar year. For occasional meetings the charge is collected retrospectively.

5. Governance

The Committee members are Trustees and meet every month; most Trustees attended every meeting. The Trustees reviewed the risk register in January and concluded that adequate arrangements for risk management were acceptable for a charity of our size.

We invite prospective Trustees to attend a meeting of the Committee as observers before seeking nominations for election. We welcomed Sue Russell as Development Co-ordinator.

We continue to use The Third Age Trust's membership, group administration and finance system for u3as (known as BEACON). We have used this to maintain contact with members.

The voting at our June AGM was undertaken virtually and by post, as permitted under our revised Constitution.

We reviewed nearly all of our policies and our Group Leaders' Handbook. We have updated these where appropriate and have published all policies on our website. In future, most policies will be reviewed every two years. We carried out portable appliance electrical testing (PAT) arrangements to ensure all items, especially those provided by members, met approved safety standards.
