GIFT AID

As a charity, the u3a can claim back tax from HM Revenue and Customs on Gift Aid donations. The amount we can claim on each gift aided subscription is 25%.

To donate, you need to pay more income and/or capital gains tax than the amount of Gift Aid claimed on **all** charitable donations you make in the relevant year. You can only gift aid your own subscription not your spouse's or partner's – they must complete their own declaration if they wish to donate. If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your tax return or ask HMRC to adjust your tax code.
