MARRIAGE RULES

Who could marry who
In England the list of forbidden marriages was drawn up by the Church of England in 1560 and remained unchanged until the 20th century. Most of the rules apply to close blood relatives but as you will see also apply to step relatives. As the first list is complicated I have given a second chart which is simplified.

These rules were mainly imposed to prevent close blood relatives marrying but you will see that Cousins are not mentioned and half siblings are not mentioned. However, it is believed that the inclusion of half siblings is implicit in the general terms 'brother' and 'sister'.

The full set of in-laws and step relatives are included to match the equivalent blood relatives of the same name except; stepsister; stepbrother; step-aunt; step-uncle; step-neice and step-nephew.

The first changes to this list were made in the 1907 Marriage Act which removed No. 17 from the forbidden list provided the first spouse in each case was deceased.

The 1921 Marriage Act removed No. 18 again provided brother or sister in each case was deceased.

The 1931 Marriage Act removed 6, 7, 8 and 9, 27, 28, 29 and 30 provided the relevant Uncle, Aunt, Niece and Nephew were dead.

The 1949 Marriage Act confirmed the previous three Acts and specifically included "half blood" relatives.

The prohibitions in this Act were based on

- 1. Consanguinity blood relationship including half blood (half blood means having on parent in common, for example, a half-brother)
- 2. Affinity relationship by marriage

The prohibited degrees apply to a wide range of family relationships and include marital and non-marital offspring. An adopted child is within the prohibited degrees in relation to its natural family and adoptive parents. However, it would appear an adopted child can marry the child of their adoptive parents.

You can marry your deceased spouse's sister or brother. This also applies if your marriage ends due to divorce. Before it was only after death. There is no legal restriction on the marriage of first cousins.
