Annual Report

The Chairman outlined the activities of the Jersey u3a over the previous twelve months. Membership stood at 235, with a few more members to be confirmed. With life returning to near normal groups attendance had fluctuated as members resumed their travel and other activities.

Finances

The Treasurer Juliette White presented the Statement of Financial Activities including income and expenditure for the year ended 31 December 2021.

The Statement reflected a healthy balance with a carry forward in the sum of £7,800.83 (£6,554.40 for 2020). Total income for 2021 was £4,268.00 (£3,962.00) whilst expenditure totalled £3,021.57 (£2,529.29). Net income was £1,246.43 (£1,432.71).

The Treasurer informed the annual general meeting that the 2021 figures still reflected the impact on the organisation of the pandemic albeit less so than in 2020. Further, there had been changes with the timing for the collection of capitation fees paid to u3a National which had slightly distorted the comparative numbers. Nevertheless, the organisation was on a secure financial setting and the outlook was positive.

The Treasurer was also pleased to report that NatWest International, our bankers, had shelved their plans (at least for now) to charge fees on charity accounts.

The Treasurer expressed her personal thanks to Graeme Witts for his examination of the accounts and his willingness to stand for the post of Examiner again.
