Members are expected to

- Abide by the terms and conditions of Oban u3a's constitution.
- Treat fellow members with respect and courtesy at all times.
- Comply with and support the decisions of the elected committee.
- Advise the committee of any change in personal details.
- Members are responsible for assessing whether their level of fitness is sufficient for the activity in which they wish to participate.

A member who has been deemed by a medical professional to lack capacity [is incapable of acting, making decisions, communicating decisions, understanding decisions; or retaining the memory of decisions, by reason of mental disorder or of inability to communicate because of physical disability] must be accompanied by a competent adult, who need not be a member.

Membership Fees

The annual fee is £20 – Reduces to £10 after 31 March, and £5 after 31 May

This includes expenses for running Oban u3a (e.g., monthly meetings), a £4 per capita payment to the Third Age Trust to whom we are affiliated (for the services they provide, including public liability insurance), a £0.15 per capita to the u3a in Scotland Network and distribution cost of the magazine Third Age Matters.
