This document is to provide new and existing committee members/Trustees with details of how to access information related to the role. The Secretary and other committee members will provide assistance in accessing this information as required and will also be available to answer any related enquiries.

The Charity Commission and the u3a National Office need to be informed of changes to the committee members. The Treasurer and Secretary will update the CC and the NO respectively.

There are 3 main aspects to this

1. Information on the Oldham and District u3a website.
2. How to access Trustee related information on the national u3a website.
3. Charity Commission Requirements

**1. Information on the Oldham and District u3a website.** Go onto the site, on the Constitution page there is a copy of the current constitution and links to Oldham specific role descriptions, policies and procedures.

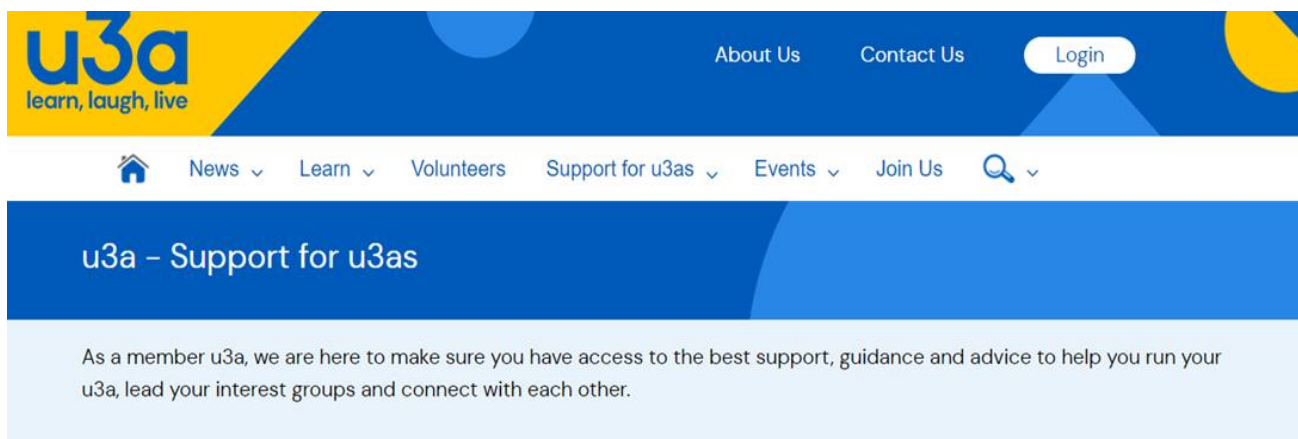
On the Members Page there are copies of recent committee meeting minutes.

## 2. Accessing information on the National Website.

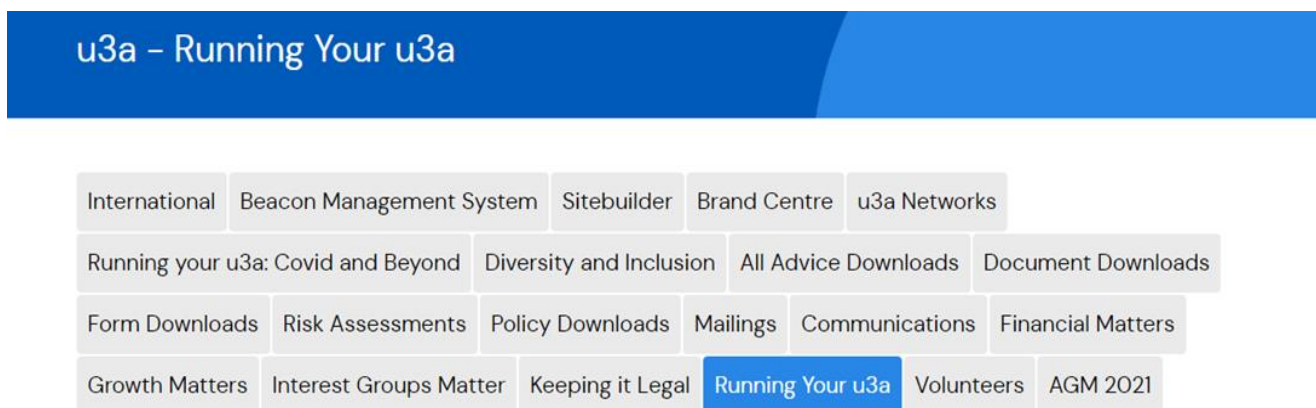

**3. Charity Commission Requirements.** New committee members need to complete a CC form which is a Declaration of suitability to be a Trustee of Oldham u3a, the Treasurer will ensure this is completed and sent to the CC.
