1. REFERENCE AND ADMINISTRATIVE DETAILS:

2. OBJECTIVES AND ACTIVITIES

The formal object of the charity is: 'the advancement of education, and in particular the education of older people and those retired from full time work, by all means including associated activities conducive to learning, and personal development in Romsey and the surrounding areas.'

We provide a programme of activities which includes monthly speaker meetings and regular interest group activities which provide members with physical, mental and social stimulation to support active living.

Members learn from each other, through sharing their knowledge, skills and experience. Our interest groups provide opportunities for physical activity, e.g. table tennis & pickleball, learning activities, e.g. Italian & Spanish, industrial heritage, study e.g. philosophy, art appreciation, opera and creativity, e.g. painting, creative writing. Our <u>current list of groups</u> is on our website

Public Benefit: Due regard has been given to complying with public benefit guidance. The charity proactively encourages and supports anyone in the local community who is no longer in full-time employment or raising a family to learn through mutual educational, creative and leisure activities.

3. STRUCTURE, GOVERNANCE AND MANAGEMENT

The charity is governed by its constitution adopted on 30th March 2022. The charity is managed by a committee of, a maximum of 12, trustees elected annually. During the period of this report it comprised:

They have met 6 times during the year.

Our u3a is part of the South West Hants u3a network which has been established as a result of merging the Southampton & District u3a network with the New Forest u3a network. Representatives of the u3as in the network meet bi-monthly to receive updates from the trustee for the South East Region of the Third Age Trust and share ideas to maintain vibrant u3as. Our Chair

has attended five of the six meetings this year and a number of other trustees have attended 'Peer Group' meetings e.g. of u3a Treasurers.

4. THE FUTURE OF ROMSEY AND DISTRICT U3A

In line with many organisations in the voluntary sector; we have found it difficult in recent years to secure a sufficient number of trustees to maintain our charity. Our, legally binding, constitution requires us to have a Chair, Vice Chair, Secretary, Treasurer and at least one other trustee. As a result of this continuing trend much of the trustees' time and attention this year has focussed on ensuring the survival of Romsey and District u3a.

On Tuesday 2nd Aug our Chair and Vice Chair met with the Chair and VC of Archway to acquaint them with the situation and explore opportunities.

After communicating the importance and urgency of identifying members willing to stand as trustees through our newsletter, in emails and at monthly meetings with little success, members were invited to an all-member afternoon tea, on Wednesday 2nd November. At this our Chair delivered a clear message about the importance and difficulty of recruiting new trustees and discussed with those present how the situation might be remedied

Following this all members were invited to attend the trustees' meeting 9 November 2022. Eleven did so and this resulted in the addition of three trustees through co-option onto the committee. A number of others indicated their intention to stand for election on 17th May 2023.

5. ACHIEVEMENTS AND PERFORMANCE

Operational roles

Our u3a is run for members by members who volunteer to undertake specific roles. Some are trustees, others lead interest groups, some look after the arrangements for our monthly meetings and others undertake communication activities. There are about 70 who do this, or roughly 10% of the membership. Without them the charity would be unable to operate.

Every person who does something for our charity e.g. trustee, group convenor, the refreshments team, is a volunteer. The trustees place on record their thanks to each and every one of them.

Membership

Membership, as in all years, has fluctuated. We are very pleased that some 70 people were attracted to join our u3a leading to a closing total of 699 members. Following the loss of our former Membership Secretary, all membership work has been overseen by our Treasurer, Sheila Prangle, until two Co-Membership Secretaries, Jan Tudball and Jean Wilks, took on the role. Jan Moody, our 'New Member Buddy', and her team continue to help our new members to settle in.

Communication with Members

We have a new newsletter editor, John Dick, who has produced a new-look edition each quarter. These were sent to all members by email, hand delivery or sent by post. Copies were also made available on the website.

These were supplemented by numerous emails on a variety of subjects ranging from warnings of online scams, to learning opportunities and events provided by the Third Age Trust.

Interest Groups

Throughout the year, we have maintained around 50 interest groups. A few groups have continued to make use of Zoom for some of their meetings and outdoor activities have been well supported.

Group leaders have reported their activities in our quarterly newsletter.

Monthly Meetings and other events

Husband and wife team, Gill and Timothy Bailey, have taken on the post of Programme Secretary this year and have exercised the role admirably.

Following the impact of Covid-19, monthly meetings are again being held in person at Crosfield Hall. Some have been held as 'hybrid' meetings. Attendance at these meetings has generally been between 75 and 100.

On 1st June 2022 all members were invited to attend a 'Picnic in the Park' (Memorial Park). Despite a sudden downpour everyone attending enjoyed themselves.

Also during June we helped to decorate the town and advertise our charity to visitors to the town centre through the annual Yarn Bombing event.

We exhibited at the 3rd July Mayor's Picnic, jointly with Archway, resulting in a number of new membership applications.

We opened our September meeting to the family and friends of all members as a contribution to the national 'u3a day' celebrations.

In November our Chair attended the Remembrance Day service and laid a wreath on members' behalf, jointly with Archway, at the town War Memorial.

On Wednesday 1st March 2023 we provided an additional monthly meeting, via Zoom, on the subject of 'sleep'.

Risk Management

The trustees recognise that they continue to have a duty of care to their members. Group convenors are required to produce risk management plans accommodating Covid-19 restrictions and health and safety risks arising from group activities. Though still not universally popular with the wider membership, and something of an administrative burden on convenors, a reasonable level of compliance has been achieved.

Website

Our website is now managed by John Dick. During the year the hosting arrangements for the site, provided by the Third Age Trust unexpectedly collapsed. This required John to 're-build' the site; a not insignificant task

Our Zoom licence is managed by Michael Ward

6. FINANCIAL REVIEW

Reserves

We maintain a reserves policy which is regularly reviewed. Our policy is to maintain a reserve of 50% or running costs averaged over the preceding 3 years.

Subscriptions

The annual subscription was raised to £15 at the commencement of this year, with members who pay their Third Age Trust capitation through another u3a, paying £11.00.

Financial Overview

Our finances were organised into three bank accounts – Main, Reserve and Groups, on a receipts and payments basis.

The Trustees agreed that the financial year would be changed to commence on the 1st March from 2023, so last year's accounts were for 11 months from 1st April 2022 to 28 February 2023. This ensured that the majority of membership subscriptions are now received in the correct financial year as our membership year runs from 1st April - 31st March.

Our main income is from Membership Subscriptions and the claiming of Gift Aid on eligible Subscriptions.

All the bank accounts had an independent auditor examine and authorise them.

Outgoings: The Third Age Trust fees include yearly Membership Fee, cost of the Third Age Magazine (TAM), plus the annual fee to use the Beacon Membership Database. This year we only purchased one yearly Licence for Zoom, as well as an option to purchase an additional large meeting licence, if required.

We continued to pay for monthly speakers who attended the monthly meeting at Crosfield Hall, with an occasional extra meeting held over Zoom.

Main Current Account: The balance at the beginning of the financial year was £4,603.30 and ended with a balance of £7,466.44

Reserve Account: The balance at the beginning of the financial year was £5,948.93 and ended with a balance of £5,954.53

Groups Bank Account: The balance at the beginning of the financial year was £9,845.17 and ended with a balance £7,041.53
