- WWW has introduced 'New Age' acolytes, "me too" social media, Photoshop fakery, drones etc
  - more noise and fewer keen ufologists: avoid!


### Gigantic UFO: JAL flight 1628 Nov 7 1986, Alaska, night. Captain's sketch of his 747 Jumbo jet, to scale







### Belgium Triangular UFOs 1989-90

In Nov 1989, 13 police officers and hundreds of other witnesses saw two silent triangular craft gliding over Belgium.

Wave of sightings there lasting well over a year.

The Belgian Air Force investigated the events in cooperation with a team of scientists and consulted with the U.S. and NATO ..... but could not find a conventional explanation.

### Most UFOs cannot be explained away as hallucinations, mirages or holograms

- UFOs land and leave traces: landing gear marks, burned soil, melted snow or ice, glowing soil, holes, Angel hair, dents, broken branches, footprints, 'sterile' earth, oily/waxy residues
- UFOs have collected: water, plants, rabbits, dog, cow, stones, fertiliser, soil, roadside dirt...abductees.
- UFOs can remotely kill vehicle or aircraft engines and headlights, and control weapon electronics
- UFOs remotely lift: horse, car, truck, aircraft, humans.

- Flying UFOs are often detected by radar (but not always), make holes in clouds or wrap in 'cloud'.
- Brlliant lights are a hallmark: flashing, pulsating, rotating, all colours even pink, hollow beams, 'slow light' /'sawn off' beams,
- UV-like skin burns on witnesses.

### Physical traces: "Angel Hair"

- Florence, 27 Oct 1954,
  - 10,000 football spectators saw several saucers release white, fibrous material that fell to cover roofs in Florence. It sublimed in the hand.
- Partial analysis by Prof Canneri: silicon, boron, magnesium (glass?)
- 70+ other instances include: Oleron and Guillac France 1954; Fatima miracle (cf Jaques Vallee)

### Physical traces: weighing a UFO from its landing marks

- Sept.10, 1954; Quarouble, France, night.
- Marius Dewilde, age 34, came out of his house when his dog was barking and saw a dark object sitting on the railroad tracks. ..... From the 5 fresh crush-marks on the timber sleepers the UFO was estimated by engineers to weigh 30 tons, the density of a submarine.
- French police and the French Air Force investigated the case. (Sources: Le Parisien, September 13, 1954; Aime Michel, Flying Saucers and the Straight Line Mystery, p. 44; Jacques Vallee, Passport to Magonia, p. 209).
- Other witnesses reported the UFO flight away.

### Only a matter of time...

- The UFO sightings selected here invite speculation that they might manipulate their local time
- The hypothesis is testable, unlike the majority of ideas about UFOs.
- The idea promoted here is not accepted physics,but physics doesn't embrace UFOs.... and the physics of time is poorly understood outside of relativity.



### Nash & Fortenberry



July 15 1952 Chesapeake Bay

Flying a DC4 at 8000 feet the two pilots were looking down on 6 discs estimated to be at 2000 feet.



### Nash & Fortenberry results:

- Observation re-enacted immediately several times. Lasted 12 seconds
- Discs were each 100 feet diameter, ca 15 thick
- Speed estimated 12,000 mph, no lower than 6000 mph.
- Reversal of direction through 150 degrees ""The only descriptive comparison we can offer is a ball ricocheting off a wall."
- two ground witnesses to 8 UFOs around same time.

### Nash & Fortenberry implications:

- 12,000 mph yet **no sonic boom** reported on ground. At 2000 feet altitude speed of sound = 750 mph
- Frictional heating at 12,000mph at 2000 feet would vapourise all known materials. (12,000 mph is space capsule re-entry speed, but into 1/000 th atmospheric density)
- The "bounce" defies inertia, intolerable G forces

### Nash & Fortenberry

HYPOTHESIS to explain all three observations:

- the UFOs envelope themselves in speeded up time, so allowing more proper seconds for events to happen.
- ca 16-fold more seconds to avoid a sonic boom
- ca 10-fold more seconds to avoid melting
- if 30mph is a tolerable speed for the 'bounce' then time needs to be speeded up 400-fold.

### An aside: UFO speeds of 1000s mph are commonplace

eg USS Nimitz 10 -16 Nov 2004.

Radar measurements of UFO descending vertically from 60,000 feet to sea level hover in a "matter of seconds" ......ca 4000 mph...and then hover at sea level

for their deployment to the Arabian Sea. The USS Princeton on several occasions detected multiple Anomalous Aerial Vehicles (AAVs) operating in and around the vicinity of the CSG. The AAVs would descend "very rapidly" from approximately 60,000 feet down to approximately 50 feet in a matter of seconds. They would then hover or stay stationary on the radar for a short time and depart at high velocities and turn rates. On 14 November after again detecting the AAV, the USS Princeton

 UFO was seen hovering by fighter pilots: "tic-tac" shape ca 45 feet long.

### Corporal Valdes' beard

April 25, 1977; Pampa Lluscuma, Chile

- 3:50 AM. Eight soldiers on a military patrol suddenly saw two large lights about 800 meters away hovering close to the ground.
  - The group's leader Cpl. Valdes approached the lights.... a bright light enveloped Valdes and he vanished in plain view of the others. They began frantically searching for him but they were unable to find him.
  - At around 4:15 a.m. Valdes suddenly reappeared. The others noticed that he appeared to have a week's growth of beard, whereas he had been clean-shaven just an hour ago, and his digital watch indicated the impossible date of April 30.

### Rapidly aged alfalfa

Trans en Provence 5pm Jan 8, 1981

 The device had the shape of two saucers, one inverted on top of the other. It must have

measured about 1.5 m in height. It was the color of lead. This device had a ridge all the way around its circumference.

It landed for ca 30 seconds




Diagram: The UFO landing at Trans-en-Provence with insert of craft seen by farmer Nicolai. Courtesy of CNES/SEPRA

### Alfalfa prematurely aged by UFO

#### mversery proportional to distance.

- Young alfalfa leaves experienced the highest loss of chlorophyll and, moreover, exhibited "signs of premature senescence".
- samples measured by university plant pathologist
- alfalfa is a perennial that goes dormant in autumn, ca 8 months after the January landing.
- senescence involves co-ordinated sequence of gene expression, the plants were not 'cooked'.
- Could the ufo have locally speeded up time?
   Sampling was 1 day after the ufo. so senescence was sped up roughly 240-fold

### The swimming pool abduction

- reported by Budd Hopkins in "Witnessed", the story of the Linda Cortile abductions in NY. p242
- Daytime abduction of LC by two 'men', from a Coney Island swimming pool changing room.
- the swimming pool was busy. LC: "You splash water. But it didn't fall down. It was like a photograph....in the pool there were splashes like that, that didn't finish...they were still up in the air. Nobody was moving, and the water in the splashes were not moving either. And we walked right by everyone frozen like that, and nobody even looked at us...like they didn't even see us"
- Freeze-frame photo of water splash: 1/1000 sec. So for say a 10 sec walk past the pool, LC's time speeded up 10,000 fold

### The "Oz factor" \*\*

- observers in proximity to a UFO report silence (ambient sounds gone) and "traffic disappearing"
- hundreds of examples reported
- within a UFO's zone of speeded-up time, sound waves entering from outside will fall in frequency, possibly below audible range.
- Traffic noise peaks at ca 1000 Hz, so to fall below audible lower limit (20 Hz) time would be 50-fold faster.
- cars moving 50-fold slower (50mph >1mph) might be described as "traffic disappearing"

### Bent headlight beams

APRIL 4, 1966, ca. 1950 hrs, BURKES FLAT, VICTORIA, AUSTRALIA.

Mr Ron Sullivan {38}, a steel construction businessman from Maryborough, was travelling at 60 mph, and approaching St Arnaut, when, in the distance, he noticed a light in a field. At first he thought it was a tractor.

"Suddenly my headlights pulled hard over to the right for some unaccountable reason. Instead of lighting the road, they lit up the fence as though they were being attracted by a magnet. I braked as hard as I could

# Burkes Flat. Beams bent by refraction?

as if an invisible lens were in front of car

- a lens works by slowing down light, by up to 3 fold in the best materials
- the UFO may be speeding up time so the beams experience a slowing of light, hence bending.

# UFO can also slow time: 'expanded time'

- 1961 a young engineer entered a ufo and experienced, as he thought, 3 hours of viewing a computer-like machine in a desert.
- He was absent for 18 days despite search parties
- He reappeared at the same location, with clean clothes, no stubble, and the flower in his button hole still fresh
- UFO time expansion: 144-fold
- source: Vallee "Invisible College" Introduction

### **Expanded vs Compacted time**

- 1961 a young engineer entered a UFO.... He was absent for 18 days.....reappeared with clean clothes, no stubble, and the flower in his button hole still fresh
- The OPPOSITE of Cpl Valdes where compacted time allowed him to grow 5 days of beard in 20 minutes absence


# Testing the hypothesis that UFOs speed up time around them

- A test of the hypothesis is mandatory, and probably feasible
- no need to capture a UFO
- high tech instruments that can do the measurements are widespread all over the world ......

# Using GPS to test the hypothesis that UFOs speed up time around them

- GPS receivers in smart phones and satnavs compare time-stamped radio signals from up to 12 satellites sychronised with one another
- radio waves are like light .....electromagnetic
- so will be affected by UFOs

### Nothing beats a measurement





## GPS test of UFOs speeding up time around them

- an "App" is needed, an engineers' task
- the major effort will be needed, as ever, to distinguish false UFO reports from genuine
- then to collate GPS
   data from several
   smart phones around
   the same UFO
- a single ufo would be predicted to distort signals from different satellites according to the angle of view of the ufo by the different smart phones.
- in flat, open country, to avoid spurious multi-path signals
- only the radio beam must be affected by the UFO, not the smart phone itself


### UFO bends searchlight beam

- The Norwood Searchlight Incident of 1949,
- 10 visual sightingsof a strange aerial object that took place in or near the Norwood, Ohio area from August 19th of 1949 to March 10th of 1950
- witnessed by civilians, by clergy, by scientists, by police officers and militaryofficials


### bendssearchlight beam

Reminiscent of Eddington's 1919 measurement of starlight bent by the sun's mass, the first proof of Einstein's General Relativity.....

# **Gravity is time and space warped by mass**



## General Relativity: Time flows slower -'dilates' - near a mass



### Kip Thorne

 Nobel Prize for black holes

Memorable description of General Relativity and gravity:

"You fall to where time flows slowest"



# "You fall to where time flows slowest"

- In Relativity time is a dependant variable, and is dilated by enormous velocities or by proximity to mass.
- We speculate here that time might be modifiable with consequent effects on gravitation.
- Compaction of time is novel to UFOs, the physics unexplored.

# "You fall to where time flows slowest"

- Do UFOs generate beams with gradients of time to lift objects?
- Objects would be moved from faster time to slower time.
- UFOs often project light beams while lifting objects. The light might be secondary to a 'beam of time'.

### **UFO** lifts a horse


- Oct 16 1954, Cier-de-Riviere.
- Guy Puyfourcat was leading a horse by the bridle when a 1.5m diameter gray object rose form the roadside and flew over them.
- The mare rose 3 m in the air and the witness had to release the rope.
- The horse fell back to ground unable to move.
- The witness felt absolutely nothing.
  - suggests the ufo can direct its influence with precision....maybe a beam

### UFO lifts a helicopter

- Mansfield, Ohio, Oct 18 1973, 11pm.
- 4 man crew US Army Reserve, also several ground witnesses.
- UFO approached fast, then hovered. It was big enough to "fill windscreen". Bathed helicopter in intense green light
- Lifted helicopter from 1700 feet to 3500 feet, while pilot's collective control was positioned to lose altitude!
- UFO flew off, helicopter controls returned to normal with a slight 'bump'

# Nine UFOs turn a Hercules C130 aircraft into a glider



6 members of a US coast Guard aircraft sighted a V formation of nine objects glowing white .....took up position above and to their left side.

The radio was dead and their radar also stopped working. Auxiliary power it too was not functioning.

At one point the airplane's engines stopped. Instead of loosing altitude it maintained "a steady altitude and course."

......after about 20 minutes the power suddenly returned and the crew was able to restart the engines in sequence.

# UFOs provided energy to fly a 33 ton glider


Gliding wiith dead engines for 20 min at 160 kts means the plane covered ca 60 miles with no engines.

The aircraft should have lost ca 15000 feet of altitude.

But the plane "held a steady altitude and course"


UFOs provided lift and compensated for drag.

Expert photoanalysis concluded the blurring is real and not shadow, motion-blurring or out-of-focus.





UFO lifts an abductee in a beam of light: Linda Cortile

- New York, Brooklyn Bridge
- Nov 13 1989. 3 am
- Budd Hopkins' book "Witnessed" is highly recommended reading. It is a complex report based upon a dozen witnesses, extends over several years, and includes a diplomat as a witness and fellow abductee, now believed to be Perez de Cuellar, Sec Gen UN.
- This abduction is just one amongst many thousands recorded.

- passed through window screen doubled-up, then straightened.

# Floated up a beam of light into a hovering UFO

(artists impression)



- recall Kip Thorne: "You fall to where time flows slowest"
- Postulate: time flows fast at the apartment end of the beam, slowest at the ufo.
- LC is falling upwards.
- Many observations exist of humanoids floating up to UFOs, and down.

### Linda Cortile abduction: physical evidence

- After the three witnesses (Perez de Cuellar and two security men) saw LC foating up the beam they next remembered seeing the UFO descend into the river
- Next, PdeC had to be helped down off the roof of his limo, without knowing how he got up there.
- All three discovered their suits were wet with sea water and sand in pockets. Samples of sand were kept (photo in book)
- Under hypnosis one of the security men recalled the three of them sitting on sandy beach while LC communicated with the small humanoids, who were digging in the sand with scooped shovels. The three had been abducted, the seawater and sand provide physical evidence.

#### Thousands of abduction cases are known.

- Prof John E Mack, (d 2004) Harvard prof of psychiatry studied 200 cases.
- Dr David M Jacobs, Temple Univ....300
- Memories, often obtained by hypnotic regression, conform to a consistent pattern and can sometimes be validated.:
  - memories of group of abductees correlate, external witnesses too.
  - scars found on abductees where memories recall biopsies
  - implanted objects seen on X-ray where memories recall surgical implantation (nose, brain, eye socket, ear)
  - two abductees in separate events and unknown to each other drew *identical* sketches of a weird biopsy tool.

### Please imagine.....

How many of you imagined 'grays' and floating up a beam of light?

- How many of you imagined being floated through a CLOSED window or door, or a wall or ceiling?
  - This is commonplace in abductees' recollections under hypnosis
- It is most unlikely that a commonlyheld dream explains floating through solids up to a UFO. Abductees are probably recalling real events.

### UFOs can vanish instantly: how?

- Solid craft with occupants, takes off and vanishes. Example: Valensole, France 5:45 am July 1, 1965.
- One of the beings
   pointed a pencil-like
   device at Masse,
   paralyzing him in his
   tracks. After
   examining the
   lavender plants the
   figures entered the
   UFO and flew away
- impressions left by UFO on ground



#### Valensole UFOs vanishes

He could see them looking at him from inside while the UFO legs whirled and retracted.

With a thump from the central pivot, the machine took off to float silently away.

At 20 metres it just disappeared, although traces of its passage in the direction of Manosque were found on lavender plants for 100 metres.

#### Valensole UFOs vanishes

Aimé Michel: How do you mean vanished? Do you mean that the speed became so great that you were no longer able to follow it with your eyes?

Maurice Masse: I can't see any other explanation. But my impression was different from that: at one moment I could see it very well; and the following instant I could no longer see anything.

# Did the UFO shrink its image with lens created from speeded up time?

- recall Burkes Flat bent headlights and the searchlight bent beam
  - conceivably the ufo instantly projected a "time lens" to suddenly refract light and shrink and defocus the ufo *image* as seen by Masse, but not the ufo itself.
  - Such an optical effect would explain Michel's remark:

Second remark: Although the Valensole object ceased to be visible at 20 metres, it left traces over more than 100 metres of a trajectory that it was *apparently* no longer occupying...)

### UFO occupants, two main types

#### "NORDICS"

#### They don't look alien enough




Might parallel evolution and galactic travel explain humanoid aliens?

# We accept there must be life elsewhere the galaxy

- Its an assumption based on the 1961 Drake Equation and the vast numbers of stars and planets in the Milky Way
- Life of some sort might well be common: few biologists would dissent, myself included
- BUT what about <u>intelligent civilisations</u>?
  - recently the Drake equation and assumptions of intelligent civilisations has been revised....

### The Drake equation



Number of technologically advanced civilizations in the Milky Way galaxy Rate of formation of **stars** in the galaxy Fraction of those stars with planetary systems Number of planets, per solar system, with an **environment** suitable for life Fraction of suitable planets on which life actually appears

Fraction of life-bearing planets on which **intelligent life** emerges

Fraction of civilizations that develop a technology that releases detectable signs of their existence into space

Length of time such civilizations release detectable signals into space

predictions of number of civilisations vary enormously, but almost all predict 'many'

Fermi: "Where is everybody?"

#### Dissolving the Fermi Paradox

Anders Sandberg, Eric Drexler and Toby Ord Future of Humanity Institute, Oxford University

June 8, 2018

Our main result is to show that proper treatment of scientific uncertainties dissolves the Fermi paradox by showing that it is not at all unlikely ex ante for us to be alone in the Milky Way, or in the observable universe. Our second result is to show that, taking account of observational bounds on the prevalence of other civilizations, our updated probabilities suggest that there is a substantial probability that we are alone. Our third result is that pessimism for the survival of hymenity based on the Fermi perodey is unfounded.

# "There is a substantial probability we are alone...."

- The most probable place to find intelligent, civilised life in our Galaxy is Earth
- Intelligent life that has human-like anatomy and physiology (eg air breathing) increases the probability of ufonauts being human

#### **Ufonaut behaviour**

- behavioural traits were not embraced by Drake or the Oxford group
- Nordic ufonauts display human behaviour: waving, shaking hands, hugging, smiling, gesturing warnings.....
- How likely are aliens to employ learned social mannerisms of us humans?

#### Was this the behaviour of an alien?

- Mourieras, France, Sept 10<sup>th</sup>. 1954, 8:30pm, farmer, Antoine Mazaud, on farm track.
- A being of average height with "helmet"-like headgear approached, bowing, with one arm held high the other extended. Shook hands, hugged farmer. Walked away, left the track crouching. Moments later, near his location, a cigar-shaped craft, 15-20 feet long, took off with low bee-like buzzing.
- A few minutes later in nearby Limoges, aerial sighting of reddish disc with blue trail, flying in same direction. independent witness
  - Aime Michel FS&SLM p40

#### Brazil, Linha Bela Vista, Dec 9 1954, evening

- Farmer saw a man of strange appearance and an unusual object hovering beyond, just some feet above the ground.
   The object was the shape of a basin or explorer's hat, cream-colored and surrounded by a smoky haze
- He saw two more strange men: one was in the craft with his head and shoulders sticking out an opening, the other was outside, apparently examining a barbed-wire fence. They were of average height, broad-shouldered, with long blond hair which blew in the wind. Their skin was extremely pale, "cadaver" pale, their slanted eyes were not normal men eyes......

- In surprise, Costa e Rosa dropped his hoe, and the stranger nearest to him came towards him, raised a hand, smiled, picked up the hoe, examined it carefully, then placed the hoe in Costa e Rosa's hands. Costa e Rosa was holding a plant of beans and a plant of maize, and the man took those and started toward the craft.
- They did not seem to mean harm to him, so he walked toward the craft. The man at the fence made a gesture which seemed to mean that he should stop; which he did.

- The visitors went in the craft, and it rose about 30 feet, accelerated suddenly, and flew away into the western sky at high speed.
- Costa e Rosa was questioned for several hours by Porto Alegre authorities. He was almost illiterate and did not read science fiction or the newspapers
- He had never heard of flying saucers.
- He thought the men must have been some aviators from a foreign country.

# Are ufonauts really ALIENS ???


The re-evaluation of Drake Equation by the Oxford University group combined with human behaviours argues against UFO occupants being alien.

The most reasonable hypothesis, with the highest probability of being correct is:



### LLandyrnog-Bodfari

8 NOVEMBER 1997 - BETWEEN BODFARI & LLANDYRNOG, DENBIGHSHIRE A family were driving along the Bodfari to Llandyrnog road (B5429) when all of a sudden their car was engulfed by purple.....a purple craft seemed to join itself to their car. The next clear memory any of the family had was that the craft was suddenly gone....like it just disappeared into thin air. They resumed their journey and could not account for considerable hours loss of time that they experienced. Margaret Fry: "The male was having trouble afterwards with a top molar tooth and he had to go to the dentist's... and a black unknown object fell out while he was at the dentist's -but he had no fillings."

Shortly afterwards, the male driver of the car reported strange happenings to local authorities. Soon he was visited on too different occasions by Air Force personnel. They warned the man to never speak of the events of 10 November 1997, publicly. The strange purple craft and missing time experienced and missing time experienced by the family was told only to a friend, who in turn related it to Fry. The names of the individuals concerned remain anonymous.
