



Clone Investment Firm Scams



You can't become complacent when it comes to protecting your money from financial criminals. Fraudsters are always working out new ways to try and outwit us. One of the latest according to reports from the Financial Conduct Authority (FCA) is the "clone firm" investment scams.

For lots of fraudsters this is a full-time job, so they have the time and expertise to try and build a relationship with you. Don't be fooled – they can be extremely persistent.

The aim of scammers is simple – to STEAL your money.

Just remember that if it seems too good to be true, it almost certainly is!

What are clone firm investment scams?

These are financial operations involving fraudsters using literature and websites that mirror those of genuine authorised firms like pension providers and investment platforms. They try to convince you that they work for a genuine company and use high-pressure sales tactics to get you to buy "investments". These "investments" are worthless and often aren't even offered by the company they're pretending to be.

5 Tips to help spot them

- 1 A seeming genuine call to promote an investment fraudsters might call you promoting an investment or offer you money in exchange for your shares. No reputable company would ever do this.
- 2 Asking you to send application forms by email scammers often ask you to send applications by unsecure email. Reputable firms would ask you to complete an application on their website or by post some do have secure email systems linked to their websites.
- 3 Trying to discuss your personal information by unsecure email reputable firms would normally ask you to use their website or by using secure messaging.
- 4 Offering to invest in a product the genuine company doesn't offer a genuine company would not make personal investment recommendations without conducting a very detailed financial analysis of your circumstances and would normally make any such recommendation in writing, backed by research documentation and a full explanation why it may be suitable foryou.
- 5 Insisting you send money by bank transfer scammers ask for money to be sent electronically to a bank account, overseas bank account or a currency exchange provider. A reputable company would normally ask you to send money using your bank debit card on their website or by providing the details using a phone call that you initiate, and to a verifiable number.

Protecting yourself from scams

Check the firm contacting your is authorised by the FCA – they authorise almost all financial services companies in the UK. If the people contacting you are not from an authorised firm it's likely to be a scam. Ask for their FCA authorised number and check that its genuine. You can check the Financial Services Register to see if a company and even an individual is registered and approved by them. Always check the register before you act – https://register.fca.org.uk/s/

Always check the firms or person you're dealing with is listed on the Register

The Register lists all the firms and individuals that are involved with regulated activities. You can find out what they are regulated to do and your protections when doing business with them.

Make sure they have permissions for the regulated activities you need

Always check that permissions/activities of the firm match the service it's providing to you.

Only use the contact details listed on the Register

Many scammers pretend to be a legitimate firm. Use the contact details on the Register to confirm you're dealing with the genuine firm before doing business with them.



Careful: if you have been contacted unexpectedly about an opportunity, it's likely to be high risk or a scam.

Advice from the FCA

What to do if you think you've been scammed

- 1 Call your bank straight away they'll be able to help with the next steps.
- 2 If you've been defrauded or experienced cybercrime, report it to Action Fraud either online: https://www.actionfraud.police.uk/ or by phone on 0300 123 2040.
- 3 If you've started a pension transfer and now suspect a scam, call you pension provider straight away. They might be able to stop it.
- 4 Report what's happened to the FCA either online (see above) or by phone 0800 1116768

Help with the emotional impact of fraud

Becoming a victim of fraud can have a huge emotional impact as well as the financial implications. Victims often feel embarrassed and don't want to tell people what's happened, even though they're not to blame.
