



## TREASURERS REPORT FOR FINANCIAL PERIOD 1/9/2022 to 31/8/23

Our finances are stable but it was decided to increase the fee of £15 to £17 for 12 month period from 1 September 2023 to the 31 August 2024 because of increasing costs and in addition we now use the Beacon System for Membership records which has streamlined the process, but does cost about £1 per member. So, for the coming year about £750 plus.

At the end of the financial year of 2022-23 we had 751 members, an increase of 61 from 690 in the previous year.

For every £17 received in membership subscriptions £4 will be paid to the Third Age Trust in the form of Annual Contributions to fund the overall administration of all U3As. The remaining subscriptions will be used to administer K2 for the coming year.

Our financial accounts showed much movement over the financial year having got back to normal following the Lockdown period and the aftermath. Many groups are arranging outings and events for their members and in addition we have a thriving General Outings group

Our areas of income are membership renewals and any tax returns from HMRC via Giftaid. This income will pay for essential services such as hire of the Citadel, rental of photocopier, postage, newsletters, insurances and other expenses including Beacon.

We will continue to reclaim tax on the £17.00 current annual subscription, for those of you who have signed a Gift Aid Declaration.

So, If you pay any income tax at all, and have not yet signed a declaration, please ask Valerie Matthews or Sylvia Lunn our Membership Secretaries for a form.

For the current tax year, we received the amount of £1502 in refunded income tax which is more than in the previous year of £740. This is because there was higher membership figure for the current tax year and more of those members claiming Gift Aid.

Each year I complete a Receipts and Payments Form showing the total amount of money spent and received. This shows the balance of funds in the current account and our COIF charity fund.

At 31 August 2023 this year the balance of funds was £14,731 in our current account and £10,000 in our charity account. Total amount £24,731 which is more than the £15,068 for year ending 2022. This is because there has been a higher number of receipts for events dated after the 31 August 2023. Those events will need payment in the near future.

In addition more members have paid their subscription for 2023-24 in the months leading up to the end of the FY of 2022-23. Whereas at the end of the previous FY fewer members had paid for the coming year of 2022-23.

I also complete a Statement of Assets and Liabilities which actually shows what K2 is worth at the end of the current FY.

#### **ASSETS**

Assets are where a prepayment has been made for an event in the new account year.

## LIABILITIES

Liabilities are payments not made to creditors during the current account year because invoices have not been received during the year. Or it could be deferred income where receipts for an event have been received in the current year for an event in the new FY.

In addition, some interest groups hold funds in the current bank account, for use by the group on request.

The total amount held in the main bank account for groups was £1432 at 31/8/23 These funds are a liability as they can be called upon at any time by the groups.

Assets are added to the total amount held in the current account and liabilities deducted from the total amount held in the current account.

Our current net worth figure for year ended 31 August 2023 was £13,116 about £1,200 more than the previous year of £11,892.

The main reasons for the higher worth figure are that Membership numbers increased during the current FY. The Gift Aid tax return for the year was higher, plus an increase in the interest paid on our charity account.

So our finances are in good order and there is no risk of the K2 bank accounts going into deficit.

The other monies not belonging in the current account year were received as deferred income. These were membership subscriptions of £5270 for 2023-24 which were received but cannot be included in the "worth" figure for the current year and also monies received for outings for future events held after the end of the current financial year.

Interest rates are gradually improving on our charity savings account because of higher interest rates.

Our accounts have been independently examined by professional accountants John A Hyde & Co at a cost of £420 including VAT. The K2 Committee accepted this figure as a reasonable charge for services.
