Please pay by bank transfer - log into your own bank account and input:

Be sure to give your membership number, if you have one, surname and initial – however you pay

Please email the form on the same day as you make the payment

If you or a member of your household living at the same address pay tax and you or the taxpayer sign and date the gift aid declaration then St Helens u3a can reclaim 25p tax on each £1 of your subscription

If you pay tax at the higher rate you can claim further tax relief in your Self-Assessment tax return
