SWIG 1 Newsletter Report for meeting Friday 2nd June 2023

Firstly a big thank you to Frank and Jim. Frank for hosting and putting on very nice cheese accompaniments to go with the wine and secondly Jim for allowing Frank the use of his house again.

Frank decided to make the evening a blind event meaning that all the bottles were covered and we had to try and decide on the grape, the country of origin, price etc

We began with a White Oyster Bay, Pinot Gris 2022 from New Zealand. This was well liked and scored an overall 7/10. It was from Asda at £9.99 and had a 12.5% alcohol level. This had us guessing as it was tricky to tell where it came from and no one guessed New Zealand!!

Next came a Spanish Blend Wild Valley white with an alcohol content of 10.5%. This was met with mixed reviews and scored a 6/10. At £3.39 from Sainsburys everyone agreed it would make a good summer afternoon in the garden drink!

Our third tasting came from France and was a very nice St Emillion Merlot which the group had more success on. It scored a very respectable 8/10. This came from Sainsburys at £10 and was 13%. There is a definite pattern arising of the higher the alcohol content the more we seemed to like it!!

Lastly the "piste de la résistance" and Frank's favourite red winner. Now, Jim knew what Frank's favourite is and was at a distinct advantage at the guessing game here!! It was a delicious French Crozes Hermitage from the Syrah grape. Bought from Majestic at £19.99 this did not disappoint and even scored a 10 from one SWIGGER. Overall it scored 8/10.

This months quiz was incorporated within the blind tasting and I think it's fair to say it was not the scoring success that Frank had hoped for, sorry Frank.(Jim won of course).

Just to remind everyone that the next meeting is on Friday June 30th again at Jim's house and he will be hosting the event.

SWIG 2 15th June 2023 Wine List

GREECE

1. ApostolosThymiopolous White:

12.0% ABV. Xinomavro and Malagousia.Majestic. £10.99

Both variety of grapes are fermented separately, with the Xinomavrojuice kept separate from the skins to avoid any red colour. It's fresh and floral with aromas of white flowers, citrus and peach. It's wonderful crisp acidity makes it an ideal match for fish dishes.

2. Athlon Assyrtiko:

12.0% ABV. Assyrtiko.Aldi. £6.99

A dry white wine from vineyards in north west Greece. Notes of lemon zest pear and stone fruits deliver refreshing acidity on the palate. It's balanced with floral notes and hints of tropical fruits. Pairs with salads, sushi and chicken.

3. KretikosBoutari:

12.0% ABV.Kotsifali and Mandilaria. The Greek Shop, Athens £9.60

Kretikos means originating from Crete, the southernmost and biggest island of Greece in the Mediterranean. Having selected the grapes from the indigenous red varieties Kotsifali and Mandilaria a balanced wine is produced with brilliant purple colour, pleasant aromas of red fruits, smooth tannins and a lingering finish. Enjoy with pasta, roasts and sharp cheeses.

4. ThymiopoulosXinomavro:

13.0% ABV. Xinomavro.Majestic. £11.99

Described as a delicious cross between Barbaresco and Pinot Grigio this example is produced by a man who's widely recognised as an expert in the art of crafting great Xinomavro. It's medium-bodied and complex with notes of red and black fruit, a vibrant acidity and a long finish. Serve with lamb shank!

I am sure that those of us on line have in the past received emails from Banks supposedly based in Nigeria announcing that one of their clients has died and left a small fortune that is looking for a home and that you are the lucky one to benefit from some poor chaps demise with the help of a bank insider.

I thought that these had all gone away, but no they are back with a new twist. I received a letter in the post, yes, in the post because I had an "unusual surname", the letter is below.

The Bank exists. The Bank has a Wealth Management Team. But there fact stops and fiction takes over.

I Googled the Bank's website and immediately adjacent to it is a string of warnings from others with "unusual" surnames who have all been recipients of the same letter so be warned, the address of the Scammer that was in Nigeria is now in China - has only moved house!

Dear Mr Livesey,

THE RISE OF THE ECO SCAMS

Since the start of the year the National Trading Standards (NTS) Scams Team are seeing a growing trend of so called 'green deal' scams. With the huge rise in gas and electricity prices the criminals are preying on our worries and concerns and are claiming to be able to provide a solution to these concerns.

It starts with a phone call out of the blue from 'your local energy adviser' or something similar stating that you are entitled to a **government grant** for energy saving products like loft insulation or solar panels and that you could save thousands of pounds by having them installed. Once they have you hooked, they then ask for a small administration fee to process the application. All they are after is your personal and financial information so they can take money from your bank. Once they have this, you won't hear from them again and the **money is gone**.

If you have received one of these calls, you should report it to Action Fraud and if you have had money stolen you should **contact your bank immediately**.

Scam Marshals! When sending in your scam mail, please remember to keep the letter/s in their original envelope and write the date it was received as it can help with our investigations! Thank You!

URGENT SCAM TEXT WARNING THAT COULD DRAIN YOUR BANK ACCOUNT

Police Scotland have this week issued a fresh warning about a scam that sends a text message with a new number asking you to contact it as soon as possible.

The text claims to be from a family member or friend and asks the recipient to text a number because their phone is 'broken', telling them it's urgent and to text them as soon as they see the message.

Example: "Hello mum, I had an incident today my phone is fully broken. I'm using a friend's phone to text you now. Pls text my new number [number here] asap, it's important x'.

It will progress to asking for money. You should try to confirm via other means (by calling the proper phone number for your family/friend) if it is genuine, and never make payments to unknown accounts or sources.

If you think someone is calling to trick you into giving them money or your personal details, hang up and report it to Action Fraud or Police Scotland (if you live in Scotland)

DIET PILL SCAM: BEWARE OF EMAILS AND SOCIAL MEDIA POSTS

Criminals are sending emails and creating social media posts promising life-changing results to people who purchase 'clinically proven' diet pills and using fake Dragons' Den endorsements to trick unsuspecting people into parting with their bank details.

This scam starts with an email from a seemingly random address, with the subject line 'Summer is almost here, jump start your weight loss now'. The email includes 'before' and 'after' images of women, alongside fake images, and unrealistic claims of losing '15-20 pounds in a month'.

The message states you must 'hurry before we sell out' - a common tactic used by criminals to rush victims into making purchases without doing their due diligence.

You should always be careful when you receive contact out of the blue or when using social media. If you receive a suspicious email, forward it to report@phishing.gov.uk

If you have entered your bank details, inform your bank immediately using the phone number on its website or the back of your card. You should also report the scam to Action Fraud.
