- Neighbours' Coffee Morning for Monday 30th October to be organised by BS u3a, at Thorley Community Centre, 10.30am. CK asked who could attend - CK, SW, JB, KB, RD, DW and LM said they could.
- EDI TMc produced some ideas for us to discuss.
- One group leader had been in touch with concerns about her group being sent people referred by a 'social prescription' from the Community Wellbeing Support Officer at the East Herts 'Healthy Hub'. She is happy to help where possible, but has been advised of our policies as a membership organisation – see below.
 - o We noted that our Accessibility Policy (which is based on TAT's recommendation) state that our u3a is a membership organisation and not a service provider, that we should make reasonable adjustments to assist people, but that there will be certain needs we will not be able to accommodate.

TMc

- The committee was reminded that Thorley u3a has an Equality, Diversity & Inclusion Policy (based on TAT's recommendation) Both this and our Accessibility Policy are on our Cloud storage.
- o We agreed that we should do all we can to accommodate any less able members. Also many groups and holiday/trip organisers go out of their way to assist.
- o CK said she believes concrete proposals are the way forward, rather than general discussions.

SW

o Rather than having 'reserved' notes on front-row seats, SW to again brief meeters and greeters to ensure people can be found suitable seats. They can ask other members to move if necessary.

TMc to investigate holding a seminar/training session TMc available to all members on how to guide people with sight problems. He is in touch with VIP (Visually Impaired Person) and the RNIB may also be able to help. TMc to bring costed proposals to the next committee meeting. VIP may also be able to refer members to us.

There is a hearing loop at the Charis Centre. CK to write a piece about this for the monthly email and to explain at the next meeting where the best place to sit is.

CK

o One member has recommended a tutor for Lip Reading and Coping Strategies for the deaf. CK to ask that member to set up an experimental group for 4 two-hour sessions to see if there is interest from our members, with a view to it becoming a permanent self-funding group. Financial help to help it set up to come out of our surplus funds, though members will still pay a sub to attend.

TMc urged a slow approach to all the above, but stressed that we do need to be more aware of how to accommodate members with particular problems. It is something that may become a bigger issue in the future with more people living longer, and having to live with physical and other 'health issues'.
