

PRIVACY POLICY

1. Introduction

Privacy

Torbay u3a (**we** or **us**) treats your privacy rights seriously. This Privacy Policy sets out the basis on which we collect and use personal data about you.

Personal Data

In this Privacy Policy, where we use the words **personal data** we use these words to describe information that is about you and which identifies you.

In this Privacy Policy:

- the word Trust means The Third Age Trust (charity number 288007)
- the word TATTL means Third Age Trust Trading Limited (company number 11899419)

This Policy describes:

- who is responsible for the personal data that we collect about you;
- the personal data we collect about you;
- how we will use it;
- who we may disclose it to; and
- your rights and choices in relation to your personal data.

This is to make sure you have a full picture of how we collect and use your personal data.

2. Who is responsible for the personal data that we collect?

2.1 We are the data controller for the purposes of data protection law, in respect of your personal data collected and used by us.

3. What personal data do we hold about you?

3.1 Collection and use

We collect and use personal data about you for the purpose of communicating with you as representative of your u3a.

This data will be held on a spreadsheet or database in secure “cloud” storage, which will provide backup security and regular additional backups will also be taken. All copies will be password protected by a non-trivial password.

Access to the spreadsheet is restricted to the Membership Secretary, and an agreed deputy. Other Members may be granted access to a copy of a subset of the data for a specific purpose such as newsletter distribution but may not access or modify the full membership database.

Group leaders will require your contact details when you join their group in order to keep you up to date with what is happening and inform you of any changes to meeting times or cancellations. If you want to share your contact details with other members of the group, this must be agreed with the group leader and documented by them.

Member’s names may be included in the Torbay u3a website with a link for people to contact them via email by clicking on their name. This is normally only necessary for committee members and group leaders and can be declined by contacting the website manager.

Members email address or other contact details will not be displayed on the website or published in the newsletter without their prior consent.

Any breach, or suspected breach, of data security will be investigated immediately and corrective action taken. Any member affected will be kept informed and a record kept of actions taken. Except in minor cases, National Office should be contacted for advice to ensure an appropriate response.

The personal data we hold includes:

3.1.1 Information that you provide to us / we collect from you:

The information that you provide to us / we collect from you may include the following:

Contact information	When you express an interest in becoming a member of Torbay u3a you will be asked to provide certain information. This includes: <ul style="list-style-type: none"> • your name • home address • email address • telephone number(s)

Subscription Preferences	An indication as to whether you want to subscribe to the Third Age Matters magazine and how you want it delivered to you (email or post).

Gift Aid Preference	An indication as to whether you want us to reclaim tax paid via Gift Aid.

Online activity information (to the extent that it constitutes personal data)	Technical information, through your internet browser or electronic device: Certain information is collected by most websites or automatically through your electronic device, such as your IP address (i.e. your computer's address on the internet), screen resolution, operating system type (Windows or Mac) and version, internet browser type and version, electronic device manufacturer and model, language, time of the visit and pages visited.

This information may be provided:

- in the course of communications between you and us (including by phone, email or otherwise);
- when you provide personal data via our website or using other systems which we provide to you;
- via our Facebook pages, other social media content, tools, and applications.

4. Information about third parties

4.1 Third parties

In the course of us communicating with you, you may provide us with personal data relating to third parties.

4.2 Consent and third parties

We will use this personal data in accordance with this Privacy Policy. If you are providing personal data to us relating to a third party, you confirm that you have the consent of the third party to share such personal data with us and that you have made the information in this Privacy Policy available to the third party.

5. How do we use the personal data we collect about you?

5.1 Purposes

We use your personal data for a variety of different purposes during the course of us providing services to you. The purposes for which we use your personal data are set out below. Under data protection law, we can only use your personal data if we have a legal basis to do so. Examples of where we have a legal basis to process your personal data, includes when:

- we have your consent;
- it is necessary to enter into or perform a contract we have with you (or to take steps at your request prior to entering into that contract);
- it is necessary to comply with a legal obligation; or
- it is in our legitimate interests to process your personal data.

5.2 Legal Basis

We have set out our reasons for using your personal data in the table below under the heading **Legal Basis**. Where we rely on our legitimate interests, we have set out those interests in the table below.

6. Automated processing

We do not use your personal data to make any automated decisions that might affect you. Who may we disclose your Personal data to?

6.1 We may share your personal data with:

- Third Age Trust and
- Third Age Trust Trading Limited and
- our service providers and business partners.

For more information, please refer to Schedules 1 and 2.

7.2 We may also disclose your personal data to other third parties, for example:

- 7.2.2** if we or substantially all of our assets are acquired by a third party (or are subject to a reorganisation within our corporate group), personal data held by us will be one of the transferred assets; and
- 7.2.3** if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply the agreements concerning you (including agreements between you and us).

7. Where will we transfer your personal data?

If we transfer personal data outside the UK or the European Economic Area (EEA), we will implement appropriate and suitable safeguards to ensure that such personal data will be protected as required by applicable data protection law.

8. How long will we keep your personal data?

9.1 Retention periods

We will keep your personal data for different periods depending on the nature of the information, the purpose for which it was collected, any legal obligation and/or business reason to retain.

9.2 Extensions

Please note that the above retention period may be extended where we need to preserve and use personal data for the purposes of bringing or defending a legal claim. In such cases, we will continue to hold and process your personal data for as long as is necessary to deal with the legal proceedings.

9. Your rights

You have certain rights with respect to your personal data. The rights will only apply in certain circumstances and are subject to certain exemptions. Please see the table below for a summary of your rights. Details of who to contact to exercise these rights can be found in paragraph 14.

	Summary of your rights
Right of access to your personal data	You have the right to receive a copy of your personal data that we hold about you and information about how we use it, subject to certain exemptions.
Right to rectify your personal data	You have the right to ask us to correct your personal data that we hold where it is incorrect or incomplete.

	Summary of your rights
	<p>To ensure the information we hold is accurate and up to date, member's need to inform the u3a as to any changes to their personal information. You can do this by contacting our membership secretary using the contact details at the end of this document.</p> <p>On an annual basis you will have the opportunity to update your information, as required, via the membership renewal process. Should you wish to view the information that the u3a holds on you, you can make this request by contacting the membership secretary. There may be certain circumstances where we are not able to comply with this request. This would include where the information may contain references to other individuals or for legal, investigative or security reasons. Otherwise, we will usually respond within one month of the request being made.</p>
Right to erasure of your personal data	<p>You have the right to ask that your personal data be deleted in certain circumstances. For example:</p> <ul style="list-style-type: none"> • where your personal data is no longer necessary in relation to the purposes for which it was collected or otherwise used; • if you withdraw your consent and there is no other legal ground for which we rely on for the continued use of your personal data; • if you object to the use of your personal data (as set out below); • if we have used your personal data unlawfully; or • if your personal data needs to be erased to comply with a legal obligation.
Right to restrict the use of your personal data	<p>You have the right to suspend our use of your personal data in certain circumstances. For example:</p> <ul style="list-style-type: none"> • where you think your personal data is inaccurate but only for so long as is required for us to verify the accuracy of your personal data; • the use of your personal data is unlawful and you oppose the erasure of your personal data and request that it is suspended instead;

	Summary of your rights
	<ul style="list-style-type: none"> • we no longer need your personal data, but your personal data is required by you for the establishment, exercise or defence of legal claims; or • you have objected to the use of your personal data and we are verifying whether our grounds for the use of your personal data override your objection.
Right to data portability	<p>You have the right to obtain your personal data in a structured, commonly used and machine-readable format and for it to be transferred to another organisation, where it is technically feasible.</p> <p>The right only applies:</p> <ul style="list-style-type: none"> • to personal data you provided to us; • where we rely on the following legal bases: <ul style="list-style-type: none"> • consent; or • for the performance of a contract; and • when the use of your personal data is carried out by automated (i.e. electronic) means.
Right to object to the use of your personal data	<p>You have the right to object to the use of your personal data in certain circumstances and subject to certain exemptions. For example:</p> <ul style="list-style-type: none"> • where you have grounds relating to your particular situation and we use your personal data for our legitimate interests (or those of a third party); • if you object to the use of your personal data for direct marketing purposes; and • where we use your personal data to take a decision which is based solely on automated processing where that decision produces a legal effect or otherwise significantly affects you.
Right to withdraw consent	<p>You have the right to withdraw your consent at any time where we rely on consent to use your personal data.</p>
Right to complain to the relevant data protection authority	<p>You have the right to complain to the relevant data protection authority, which is in the case of us, the Information Commissioner's Office (ICO), where you think</p>

	Summary of your rights
	<p>we have not used your personal data in accordance with data protection law. The ICO's contact details are:</p> <p>Information Commissioner's Office Wycliffe House Water Lane Wilmslow Cheshire SK9 5AF</p>

10. Third party links

Our website may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for how they handle your personal data. When you leave our website, we encourage you to read the privacy notice of every website you visit.

11. Cookies

Many websites use cookies to distinguish you from other users. This helps them to provide you with a good experience when you browse the Website. We currently do not use cookies for our website. If we introduce them at some point in the future, this document will be updated.

12. Photography

From time to time, we may take photographs at our activities and meetings for publication in our newsletter or on our website. We also routinely take photographs of individual committee members for publication on our website. These photographs are classified as personal data.

Consent will be obtained from members for photographs to be taken at the time and members will be told where photographs will be displayed, which is likely to be in our website gallery or in our newsletter. Members will be asked to step out of shot if they don't wish to be in group photographs. A member may withdraw their consent and have their photograph removed by contacting the membership secretary (see below for contact details).

13. Changes to our privacy policy

This Privacy Policy is available on the Documents page of our website www.torbayu3a.org.uk. This policy may change from time to time. Members will be

informed via the newsletter and the monthly meetings when any material changes are made to Torbay u3a's policies and procedures.
