DCW ideally require a minimum of four participants; there is no maximum. The sessions can be held via Zoom / Teams / Click Meeting. There are some slots available for face-to-face training but these will require 12 weeks advance booking, whereas webinar sessions require 2 weeks in advance. **There is no charge for any digital training sessions**.

Skills Audits have been developed by DCW, which can help organisations to understand current skill levels and support the development of the digital confidence of members. There is no charge for the skills audits. The results of which will inform of future training needs.
