# Membership

Our membership year runs from 1<sup>st</sup> January to 31<sup>st</sup> December annually but new members are welcome to join at any time during the year. Membership renewal forms are sent out each November and must be received, signed and dated, by 31 December latest to comply with Data Protection Laws.

## PRIVACY STATEMENT

Wonersh U3A requires members to provide personal information so that you can be kept informed about events and activities that are offered as part of your membership. In collecting your information Wonersh U3A will:

- Store it securely
- Use it to communicate with you as a U3A member.
- Share your information with group leaders/conveners for those groups of which you are a member.
- Send you general information about the Third Age Trust\*

\*The Third Age Trust is the national office to which all U3As are affiliated.

## Gift Aid

**The Benefits:** If you are a UK taxpayer and eligible to Gift Aid your payment this will increase the value of your subscription to us and will COST YOU NOTHING MORE. We need as many of you as possible to assist us in this way to help us to hold down our membership fees. Gift Aid is linked to basic rate tax, currently 20%, which allows charities to reclaim 25p for every £1 donated.

**The Declaration** is for no fixed duration and may be cancelled at any time.

## NOTES

1. As our membership is individual, joint declarations are not acceptable.
2. You must pay an annual amount of Income and / or Capital Gains Tax as stated on your declaration.
3. We can benefit even if you only pay tax at the 10% rate. Where income is from dividends, the tax credit is eligible for tax recovery.
4. If you pay tax at the higher or additional rate, you can claim further tax relief in your self-assessment tax return.
5. Please notify the Membership Secretary if you:
  - Want to cancel this declaration
  - Change your name or home address
  - No longer pay sufficient tax on your income and/or capital gains.
